### **TERMS OF REFERENCE – ACTIVITIES AND BUDGET**

### 1. Background Information – South China Sea SAP (SCS SAP) Project

The South China Sea is a strategic body of water surrounded by nations that are currently at the helm of industrialization and rapid economic growth in the Asia-Pacific region. Recent reports identified coastal communities bordering the South China Sea and Gulf of Thailand as being among the most at risk globally from coastal and marine environmental degradation. This issue has been acknowledged by the countries of the South China Sea, who have committed to a 20-year process of cooperation to reverse environmental degradation trends. This is evidenced by the intergovernmental endorsement of the Strategic Action Programme for the South China by Cambodia, China, Indonesia, Malaysia, Philippines, Thailand and Vietnam. This commitment was further reinforced in 2016 when the abovementioned countries signed a special Memorandum of Understanding (MoU) committing to cooperate with one another to implement the Strategic Action Programme (SAP).

This commitment provided a clear signal to the International community to support the financing of the SAP through various projects, including the project entitled "Implementing the Strategic Action Programme for the South China Sea and Gulf of Thailand (SCS SAP Project)". The project objective is to assist countries in meeting the targets of the approved Strategic Action Programme (SAP) for the marine and coastal environment of the South China Sea and Gulf of Thailand through implementation of the National Action Plans in support of the SAP, and strengthening regional co-ordination for South China Sea and Gulf of Thailand SAP implementation. The project aims to address habitat degradation, land-based pollution and regional cooperation through its three Components (as presented below).

# Implementing the Strategic Action Programme for the South China Sea and Gulf of Thailand

# Component 1. Reducing habitat degradation and loss via national and local reforms to achieve Strategic Action Programme targets for coastal habitat management in the South China Sea

- Outcome 1.1 Appropriate forms of sustainable management established for 860,000 ha of mangrove by Yr
- Outcome 1.2 153,000 ha of coral reef at 82 priority sites managed sustainably by Yr 5, including a reduction in the decadal rate of degradation in live coral cover from 16 to 5%
- Outcome 1.3 Conservation, management and sustainable use of 25,900 ha of known seagrass area in the South China Sea by Yr
- Outcome 1.4 Integrated management of 783,900 ha of coastal wetland at 19 sites, including habitat restoration and
  protection strengthened at priority locations
- Outcome 1.5 National and regional level cooperation in tracking results of SAP actions for coastal habitat management

Component 2. Strengthening knowledge-based action planning for the management of coastal habitats and land-based pollution to reduce environmental degradation of the South China Sea

- Outcome 2.1 Enhanced information-base for coastal habitat management, monitoring and action planning
- Outcome 2.2 Effective integration of regional science in the management of land-based pollution
- Outcome 2.3 Strengthened and harmonized national policies and laws, and supporting financial mechanism, for the management of habitats and land-based sources of pollution
- Outcome 2.4 Improved national and regional values for the Updated Total Economic Values of coastal habitats for use in development planning and decision-making and blue economy
- Outcome 2.5 Regionally appropriate tools and mechanisms to guide the development of sustainable management systems for coastal habitats and land-based pollution
- Outcome 2.6 Updated and Ministerially adopted Transboundary Diagnostic Analysis and Strategic Action Programme, including prioritization of national management actions to address climate variability and change

# Component 3. Facilitating regional and national level integration and cooperation for implementation of the South China Sea Strategic Action Programme

- Outcome 3.1 Regional and sub-regional co-operation in the integration of scientific knowledge and research outputs with management and policy making
- Outcome 3.2 Capacity for civil society and community organization participation in SAP implementation strengthened via operational partnership with GEF SGP
- Outcome 3.3 Relationships between central and local governments and the private sector strengthened and formalized
- Outcome 3.4 Revitalization of regional mechanisms for communications, knowledge exchange, and information and data management and sharing
- Outcome 3.5 Agreed arrangements for strengthened regional cooperation in the management of the marine and coastal environment of the South China Sea

### 2. Purpose of the Inception Phase, deliverables and timeline

The purpose of the Inception Phase of a project is to fully elaborate and detail activities, workplan and budget as well as to identify the execution arrangements, partners and stakeholders for each output and/or activity and prepare terms of references (ToRs) for staff, consultants and draft contracts for execution of activities. It is also an opportunity in some cases to adjust project deliverables to be aligned with any new global, regional and national initiatives and create partnerships. In the case of the SCS SAP, this is especially key as the SAP was adopted in 2008, and whilst overall the targets and identified actions are still valid in 2020, some review of the sites and ensuring alignment with new

processes is essential to strengthen the project and ensure real sustainable impact of actions to be implemented. In addition to new regional and national processes, at the global level the Agenda 2030 on Sustainable Development includes a number of SDG targets and indicators are relevant the marine and coastal environment. The United Nations Framework Convention on Climate Change (UNFCCC) has near universal membership (197 Parties) and is the parent treaty of the 2015 Paris Agreement [LINK]. Also work is ongoing to develop the Post 2020 Biodiversity Framework [LINK] which includes regional and thematic consultations, such as on Marine and Coastal Biodiversity for the Post-2020 Global Biodiversity Framework (see workshop report held in November 2019 [LINK]).

The Inception Phase deliverables are summarized below and will be presented for final approval at the Inception Meeting/1st Steering Committee Meeting to be held in early 2021.

### Participating countries role and contribution

National coordination of the SCS SAP project will be ensured through the following national committees and working groups: Inter-Ministry Committee (IMC), National Technical Working Group (NTWG) and National Committees (NCs). The chairpersons of the IMC and NTWG will take the lead role in the Inception Phase, with the support of NTWG, NC and other experts as appropriate.

The nomination (or re-confirmation) of the chairpersons of the IMC and NTWG is the first step, followed by the remainder of IMC and NTWG members to ensure national consultations engage all key experts, institutions or ministries and stakeholders.

Under the guidance of the IMC and NTWG, the following inputs are expected during the Inception Phase:

- ✓ Initiate first IMC and NTWG meetings and memberships, and agree on work-plan for Inception Phase;
- ✓ Review all relevant national reports from the 1<sup>st</sup> South China Sea project [LINK]
- ✓ Further develop and finalize the National Implementation Reports (see next section for further details) for the Inception Meeting/1st Steering Committee Meeting;
- Ensure national consultations and inclusion of relevant stakeholders in development of activities, work-plan and budget. This should also include inter-ministerial coordination, coordination with relevant initiatives and projects, and aligning with national commitments and reporting to global Conventions and processes (i.e. SDGs, CBD etc.);

- ✓ Review the compiled regional-level Inception Phase documents, including project results framework, workplan and budget etc., and provide comments and suggestions as appropriate;
- Participate in the Inception Meeting/1st Steering Committee Meeting to be held in late 2020 or early 2021
- ✓ This will lead to the establishment of national teams for the execution of national activities, execution of national activities

It should be noted that Component 1 of the SCS SAP project is fully executed at the national level. Components 2 and 3 include a mixture of activities executed at the regional and the national level. Therefore, the NIRs will also be further developed to include national actions under Component 2 and 3 in the following 1-2 months. Currently approximately **640,000 USD** are available in total for each country to cover all sites under Component 1, depending on the cost of the activities. Where critical activities require more financing, this will be discussed with UNEP, UNOPS and the Inception Phase Team to find possible solutions through overall changes to the budget. During the development of activities, national consultations should include organizations, initiatives, private sector that may provide co-financing.
